## 13/01/09 Request for Grit Bins on the Colt Close Road.

Discussion took place regarding potential grit bins on the Colt Close road, after discussion councillors felt that this was a long stretch of road and there was a good possibility that grit bins would not necessarily be located in the right area when needed. It was unanimously agreed that several heaps of grit would be more beneficial for road users. The clerk agreed to write to Mr Brian Ruddick and request that grit heaps could be put on this road when conditions were bad.

## 13/01/10 Footway Lighting – Plumpton.

Some residents from Plumpton had approached councillors regarding the re-installation of a light near Petterill Terrace. The clerk had looked into this with Eden District Council and approximate figures were £3350 plus VAT. After discussion councillors felt that it was not financially viable at the moment.

## 13/01/11 Recreation land at Calthwaite – Update

Mr Porter reported to the council that he and Mrs Jones had met with Mr Paul Foote Solicitor from Eden District Council to discuss the proposed lease of the above land, Mrs Jones and Mr Porter had also walked the recreation fields looking for potential hazards etc:- The conclusion from the meetings identified the following points that needed looking into:-

- 1. Replacement of the fence near the stream.
- 2. Residents needed denied access to the field behind Lakin View eg. a padlock on the gate from the recreation field.
- 3. Signs needed to be put up stating that people used the facilities at their own risk.
- 4. Mr Foote noticed that a copy of the plan showing the landlords roadway was not included in the lease contract.

Mrs Jones agreed to write to Mr Harris and his agent Dickson Dees and request that the above items were looked into, before the council agreed to sign the lease.
