08/11/10 Request for Funding – Ivegill Village Hall Defibrillator/Green Acres, Plumpton

A request for joint purchasing of a defibrillator had been received from Skelton Parish Council, the proposed location for this defibrillator is Ivegill Village Hall. Councillors discussed this request and unanimously agreed to donate £250.00. The clerk was asked to write to Skelton Parish Council clerk and agree to make a £250.00 payment when the defibrillator was ordered.

A request had been received regarding a proposed defibrillator at Greenacres at Plumpton, after discussion Councillor's decided not to make a donation towards purchasing this defibrillator, because a previous donation had been made to the defibrillator which is sited at Plumpton School.

08/11/11 Update Land at Crooks Mill

Brief discussion took place about the Land at Crooks Mill and it was agreed that a site visit should take place before the HPC January meeting. It was also agreed that the Grass Cutting Tender should be put in The Herald and the Cumberland News.

08/11/15 Plumpton Flood Defence, Beckside – Update

Mrs E Martin updated the council on the ongoing flood defence at Plumpton. “Excess water from the quarry is travelling over the A6 1) *Dig a field drain to cope with this water* 2) *Raise the height of the Brown Sike Culvert by 300 mm in Plumpton Village. The proposed work would be carried out during school summer holidays 2017.* A letter had been received from a Plumpton resident requesting financial support towards purchasing of flood defence items including a storage bin, synthetic sandbags and hydro snakes. After discussion councilors unanimously agreed that the clerk should write to the resident and suggest residents contact EDC for sand etc.
