The Council would like to invite you to submit a tender for the following work.

## Specification

### Background

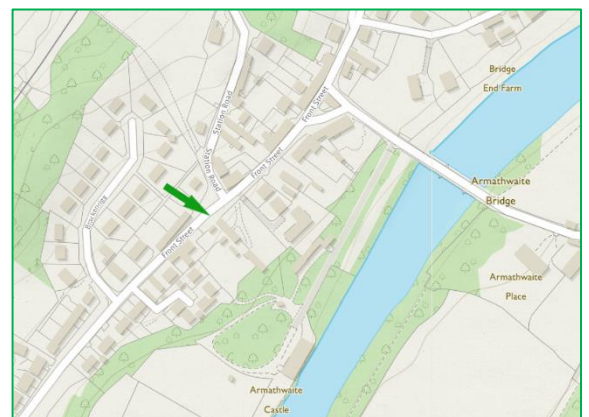
Following a tree survey commissioned by the Parish Council, required arboreal work has been identified at Front Street, Armathwaite.

### Requirements

The trees are located on a strip of land along Front Street, in front of a property named Glen Artney, opposite the turning for Station Road, as illustrated on the map opposite. There is also a noticeboard and bench located on the land.

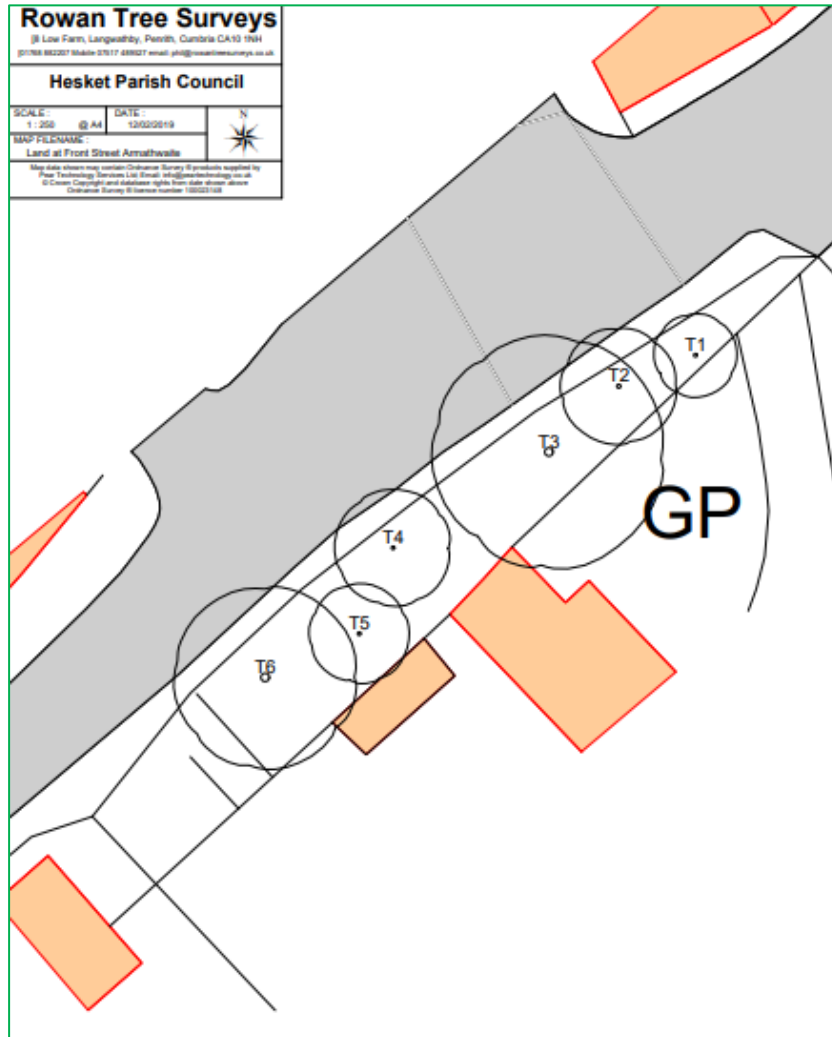
Eden District Council have confirmed that there are no Tree Protection Orders in place on the land concerned.

All work should be completed before 31<sup>st</sup> March 2020, to avoid nesting season.



## Hesket Parish Council

The following work is required:



- T1 – Mature laburnum, roughly 5m in height.
  - Remove lowest branch growing towards sign.
- T2 – Mature sorbus, roughly 8m in height.
  - Cut back to clear lamp column by 1.5m.
- T3 – Early-mature horse oak, roughly 16m in height.
  - Remove deadwood.
- T4 – Mature ornamental apple, roughly 4.5m in height.
  - Due to low growth, requires crown lift to 2m.
- T5 – Mature ornamental apple, roughly 5m in height.
  - No action required.
- T6 – Mature Norway apple, roughly 14m in height.
  - Prune to clear wires by up to 0.5m; tidy stubs.

All branches/debris to be cleared on completion.

\*Please note, all contractors must have appropriate liability insurance.
