5/23/10 Annual Accounts: RESOLVED that the financial summary was considered, but that due to a delay with the internal audit, these would be approved at the next meeting of the Parish Council in July.

Policy updates: RESOLVED that the policies of the Parish Council had been reviewed by the Clerk and that no updates were required at this time.

Westmorland and Furness Council: RESOLVED that Councillor Carrick informed the Council that Westmorland and Furness Council been in operation for 6 weeks. The Council is still in its formative stages, with staff from former authorities transferred into the two new authorities. The Council is aiming for greater local engagement and has formed three Locality boards, along the bounds of the three former districts. Councillors from those meet regularly. The Eden Locality Board has elected John Murray from Kirby Stephen as Chair and Lorna Baker form Kirby Thore as Vice-Chair. Hesket Councillor Colin Atkinson was appointed as a representative on the Armathwaite Old School Hall Committee. A Community Grants scheme introduced has been introduce, with up to £5000 for any community projects. Councillor Carrick further informed the meeting that planning decisions will be taken on two levels – a Strategic Planning Committee for infrastructure applications which will have representatives from across the Council area, on which Councillor Carrick will sit, and three Locality Planning Committees, from each of the former

Districts, for other planning. Councillor Atkinson will sit on the Eden board.
