O5/24/1 Election of Chair: RESOLVED that Elaine Martin was unanimously elected as Chair for 2024-2025. (Nominated by Councillor Gibson, seconded by Councillor Peacock)

O5/24/2 Election of Vice-Chair: RESOLVED that David Ryland was unanimously elected as Vice-Chair for 2024-2025. (Nomination by Councillor Martin, seconded by Councillor Campbell)

05/24/3 Apologies for absence: RESOLVED that the following apologies were received;

- **Declaration of interests: RESOLVED** that Councillor Campbell and Councillor Waugh declared an interest in item 18 on the agenda (minute number 05/24/18).
- **O5/24/5 Minutes: RESOLVED** that the minutes of the Ordinary Parish Council Meeting held on Tuesday 12th March 2024 were confirmed as a true record and will be signed by the Chair at the July 9th meeting of the Parish Council.
- **Matters arising from the minutes: RESOLVED** that the Clerk confirmed that Westmorland and Furness Council were now proceeding with their review of footway lighting across the whole of the new Council area. The Police Report for April had also now been received, with the following items of note;

 - 17th February Reports of males shining torches into properties intercepted and arrested for public order and drug offences and vehicles seized;

O5/24/7 Chair's announcements: RESOLVED that no announcements were made.

O5/24/8 Public Participation: RESOLVED that no matters were raised.

O5/24/9 Annual Accounts: RESOLVED that these were approved by the Council and signed by the Chair and the Clerk.

O5/24/10 Policy Updates: RESOLVED that Council policies had been reviewed by the Clerk, and the following updates were required:

- a) Financial Regulations NALC have supplied an updated version of the Financial Regulations, which is substantially different to the previous version. The Clerk will review and provide an update on changes to Councillors, to be approved at the July meeting of the Parish Council.
- b) Asset Register An updated Asset Register has been circulated to Councillors. **RESOLVED** to adopt the new Asset Register.

05/24/11 Westmorland and Furness Report: RESOLVED

Councillor Carrick updated the Council with regard to the following matters;

- The planning application at Blaze Fell for the Luge is no longer on the May planning committee agenda and may be put forward in July.
- Councillor Carrick has spoken to Highways with regard to the road at Gillians Well following completion of building works, who confirmed they have before and after images of its condition. Councillor Carrick will also raise the issue of repair to the well.
- With regards to flooding on the A6 at Cross Keys, Highways confirmed that this has been caused by a three blocked gullies two of which have been cleared, with the third due to be done in June.
- With regards to the layby on the A6 adjacent to the school at High Hesket, Highways have agreed to close the layby and revert back to verge, as per the Parish Council's request.
- The Planting for Pollinators Project, co-ordinated by Cumbria Wildlife Trust, have visited the wildlife garden behind the Old School Hall, Armathwaite, and were impressed the work that had begun. They would be providing further advice and assistance to help it develop.
- Councillor Carrick confirmed that the first 20mph schemes had been selected. She
 was also able to confirm that speed monitoring had been conducted in the Parish, at
 Plumpton, Low Hesket and Aiketgate, at her request, with the following
 observations:
 - Plumpton opposite Byrnes Close, an average speed of 22.5mph was recorded, and opposite Fairfield, an average speed of 28.4mph. Highways have requested further enforcement from the Police at this second location, and will look at signage and road markings. (It was noted that the Parish Council will be making use of their Speed Indicator Device at this second location).
 - Low Hesket opposite 3 Mill Bank and at the Rose and Crown. Both locations had averages around 40mph, but also a significant number up to 45mph, with additional enforcement measures recommended.
 - Aiketgate by Aiketgate Farm, an average speed of 23.5mph, with 85% at less than 30mph, meaning no further action to be taken.
- Councillor Carrick further updated the Council that Westmorland and Furness Council were in the process of producing plans and strategies for the rest of the current term, with work also beginning on the new Local Plan for planning policy.
- Programme in to dispatch layby, back to verge.

- **O5/24/16** Play Area: RESOLVED that Westmorland and Furness had agreed to provide a grant previously awarded by Eden District Council. The Clerk was authorised to proceed with path on receipt of grant, on condition that costs fell within allocated funding amount.
- **O5/24/17** Planting at Armathwaite: RESOLVED that a report had been received report from the Helping Armathwaite Wildlife Group regarding grant funding spending. It was further RESOLVED to allow Gill Andrews to caretake the grass verge, to be reviewed in 12 months' time.

 - a) The signs at the top of Station Road in Armathwaite are being repeatedly damaged, as wagons have to turn. Issues appear to be arising from lorries taking the wrong route to the water bottling factory. Clerk to request further signage on the A6.
 - b) Councillor Lon agreed to inspect the bench in Calthwaite for condition.
 - c) The Clerk informed the Council that the printer was now beyond repair, and requested that it be disposed of, with future printing to be charged per sheet, on the Clerk's own printer. **RESOLVED** that Councillors agreed.
- **05/24/24 Council matters: RESOLVED** that the following matters were raised.
 - a) **Petteril Bank Bridge Ford Crossing** signs have been erected which are blocking footway to bridge, one of which is now in the in river. Concerns were raised that the signs are obtrusive and spoil the look of the area. Clerk to raise concerns.
 - b) **Bridge at Plumpton** ongoing concerns regarding condition, Clerk to follow up with Environment Agency.
 - c) **Drain in Plumpton by Jubilee Chair at Petteril Bridge** sunken drain with edging stones fallen. Clerk to report.
 - d) **Calthwaite Noticeboard** to purchase a new noticeboard, as per the Plumpton one.
 - e) Trees Southwaite these have now been cut back.
 - f) **Seat in Southwaite** Councillor Waugh reported that strimming had now been done around the bench, with arm pieces fixed.
 - g) Seat on A6 Clerk to request Neil Ruddick to cut grass.
