a) **22/0314** - Coombs View Too, Armathwaite, Carlisle. Replacement of existing conservatory structure with new extension

b) 22/0336 - Land Adjacent to Elm Close. High Hesket. Erection of 33 dwellings.

Members of the public voiced their concerns regarding the proposal, in particular regarding access to the proposed development, parking, lack of facilities in the area, restricted public transport, loss of privacy, noise impact to new residents, environmental impact, and concerns over the sewage disposal proposals. **RESOLVED** that the Parish Council agreed to support residents objections.

**Objections** – On the grounds of physical infrastructure, highways matters, social facilities, noise, overlooking and affordable housing. Further, the Clerk was instructed to comment on environmental concerns and concerns over the potential construction period.

c) **22/0354** - Southwaite Motorway Services Area South, Southwaite. Installation of a pre-fabricated Changing Places facility to the side of the existing rear coach park entrance to the amenity building.

d) **22/0383** - Castle Farm, Low Hesket, Carlisle. Outline application for the demolition of existing agricultural buildings and redevelopment of steading for residential development, with approval sought for access and scale
