## 14/11/08 CCC – Tom Wentworth-Waites Update

- Annual funding plan Grants for community groups. Tom explained that, although there is no deadline, it
  was an ideal time to submit applications (contact Tracey Moran or go through Tom). Additionally the
  Norton IT fund was still available. Reminder that funding runs to end of the financial year.
- Tom noted that Mr Remmington (Southwaite) had submitted concerns regarding tractors and trailers speeding through the village. Rory Stewart MP has been informed and is working with Tom to raise the issue further.
- Similarly, Elaine has been in touch with Sarah Watson (Head of Environment / Planning) to confirm whether there are planning stipulations which state that farming related transport should not be brought in from other areas other that for specific land use e.g for transfer and transportation of grass.
- Barry Davidson noted that improvements have been made to driving conduct after discussions with local farmers and their drivers.
- Agreed that routes need to be looked into which will cause less impact on the community. Conscious that the routes need to be suitable (financially) for farmers too. One particular route that needs revision is under Southwaite Bridge, which is suffering damage from oversized vehicles.
