Minutes of the Ordinary Parish Council Meeting of Hesket Parish Council held on Tuesday 11th March 2025 at 7.30pm at Armathwaite Old School Hall.

- 03/25/1** **Apologies for absence: RESOLVED that the following apologies were received;**
- a) Councillor Ryland, due to prior commitment.
 - b) Councillor Pollock, due to prior commitment.
 - c) Councillor Waugh, due to vacation.
 - d) Councillor Everingham, due to illness (apologies received following the meeting).
- 03/25/2** **Declaration of interests: RESOLVED** that there were no declarations of interest to be made.
- 03/25/3** **Minutes: RESOLVED** that the minutes of the Ordinary Parish Council Meeting held on Tuesday 14th January 2025 were confirmed as a true record and were signed by the Chair.
- 03/25/4** **Matters arising from the minutes: RESOLVED** that the following matters were raised;
- Councillor Williams offered apologies for absence from previous meeting.
 - Highways had contacted the Clerk regarding signage for the Eden Valley Mineral Water Company, which would be erected on the A6, to avoid issues with the signs at the top of Station Road Armathwaite. These are also scheduled to be replaced/re-sited.
- 03/25/5** **Chair's announcements: RESOLVED** that no announcements were made.
- 03/25/6** **Public Participation: RESOLVED** that no issues were raised.
- 03/25/7** **Westmorland and Furness Report: RESOLVED** that Councillor Carrick updated the Council with regard to the following matters;
- a) Westmorland and Furness held its' budget meeting and agree a 4.99% total increase in Council Tax, with charges increasing by a nominal 1.7%.
 - b) Following a joint application to central government for consideration of priority status for devolution by Westmorland and Furness and Cumberland Councils, a public consultation has been regarding the creation of a Cumbrian Mayoral Authority.
- 03/25/8** **Cumbria Police Report: RESOLVED** that PC Labram had provided a report, which had been circulated to Councillors.
- 03/25/9** **Speed Indicator Device: RESOLVED** that Councillors were informed the device is now up in Plumpton. However, one of the poles in Plumpton was too close to a building to install the device, and the pole in Armathwaite was deemed unsuitable to hold the device as it was too narrow. Highways have acknowledged that the error was on their part, and will cover the costs of locating the poles, as well as any additional installation costs from the manufacturer. It was further **RESOLVED** that the Council wished to have the second device placed in a location as previously agreed in Plumpton, and that the repeater sign should be reinstalled on the current pole. The Clerk was further requested to confirm a timescale for installation of new poles, and to request consideration of a graduated speed limit reduction scheme in Southwaite.
- 03/25/10** **Place Action Group: RESOLVED** that the Chair and the Clerk had attended the meeting, where funds of £6,000 had been allocated as follows - £3,000 to resurface recycling centre at Lazonby, £1,500 to develop a waymarking map at Great Salkeld and £1,500 to investigate green waste composting schemes at Hesket and Skelton. The Chair has also raised the issue

of safe walking routes to Armathwaite School, which the group coordinator would raise with Officers, and report back.

Cumbria Constabulary Meeting: RESOLVED to that the Council wished to be represented, and that the Clerk would confirm attendance once the date and time of the meeting was provided.

- a) A tree has fallen down in the wind at Armathwaite Play Area. This has now been cleared by the contractor previously engaged to conduct tree work done.
- b) The Chair was concerned about the land behind the play area, as some of these trees have come down in the high winds. The Chair has been in touch with new owners to alert of them of the concern.
- c) Barrock Park Bridge is now open.
- d) The Clerk was requested to look at options for repairs to the wall at Gillians Well.
- e) The footway light at Plumpton, near Brockley More farm is flickering, Clerk to report.

- a) Following a recent accident involving a school bus, lines at Ivegill junction need repainting. Chair to meet with highways, in conjunction with Skelton Parish Council.
- b) Between Low Street Farm and Hallrigg Farm there is a large pothole.

- d) Stonework at Petteril Bridge is damaged, Clerk to report.
- e) Signs at ford in Southwaite are still causing an obstruction.
- f) A request was made for "Cars Turning" signs to be situated near to Court Thorn Surgery.
- g) Between the Golden Fleece and Low Hesket there are lots of bottles or urine left behind by lorry driver. Clerk to request consideration of no parking signs or litter bins.
- h) It was agreed to discuss a formal opening at Armathwaite Play Area at the May meeting.
