

# Hesket Parish Council

## Minutes of the Ordinary Parish Council Meeting of Hesket Parish Council held on Tuesday 2<sup>nd</sup> September 2025 at 7.30pm at Low Hesket Village Hall.

- 09/25/1**      **Apologies for absences: RESOLVED** that there were no apologies to be received.
- 09/25/2**      **Declarations of interest: RESOLVED** that Councillor Harris declared an interest in items 9 (minute number 09/25/9) and 11 (minute number 09/25/11) on the agenda.
- 09/25/3**      **Minutes: RESOLVED** that the minutes of the Ordinary Parish Council Meeting held on Tuesday 8<sup>th</sup> July 2025 were confirmed as a true record and were signed by the Chair.
- 09/25/4**      **Matters arising from the minutes: RESOLVED** that Councillor Graham questioned whether comments were submitted by the Parish Council on a planning application at Brockley Moor, Plumpton, Clerk to clarify.
- 09/25/5**      **Chair's announcements: RESOLVED** that there were no announcements made.
- 09/25/6**      **Public Participation: RESOLVED** that there were no matters raised.
- 09/25/7**      **Westmorland and Furness Report: RESOLVED** that Councillor Carrick informed the meeting of the following matters;
- Devolution – The outcome of the statutory consultation has now been published, with the majority of respondents against the creation of a mayoral authority. The proposal is moving forward, and central government have agreed to a request to defer any election from 2026 to 2027. Westmorland and Furness Council will be holding a special meeting on 29<sup>th</sup> September to agree to creation of mayoral authority.
  - Waste review - Cabinet will be meeting to discuss harmonised waste collections across the council area. They are likely to recommend fortnightly alternate collections. The final decision will be made in February regarding charging for green waste.
  - Call for sites for the Local Plan – no indication at present when consultation will open.
  - SID – As installation in Armathwaite, and the second unit in Plumpton, continue to be delayed, the device will move to Calthwaite next. Councillor Ryland noted that the delay in installation in Armathwaite was particularly regrettable given the communities active role in petitioning the Parish Council to purchase a device.
  - Councillor Harris queried as to whether Westmorland and Furness Council were instigating action to divest from association with Israeli associated firms, in particular in relation to pensions. Councillor Carrick confirmed that opinions are to be discussed at an upcoming meeting of the pensions committee. Councillor Harris wished his objection to local councils concerning themselves with international matters better suited to national government be noted.
- 09/25/8**      **Cumbria Police Report: RESOLVED** that PCSO Labram had provided an update, which was circulated to Councillors. PCSO Labram also encouraged all residents to report stolen number plates, as these can be used in major crimes.
- 09/25/9**      **Calthwaite Recycling Centre: RESOLVED** that Councillor Harris had met with Officers at Calthwaite to discuss relocating the recycling centre, as it is currently encroaching on the public house car park. Councillor Harris has found three potential alternative sites. However, officers

advised that new groundwork and fencing would be required for a new site, and as bring sites would be under review in the near future, funding would not be readily available at this time.

**09/25/10 Green Waste: RESOLVED** that progress has currently stalled regarding provision of compost bins for residents not currently in receipt of green waste bins.

**09/25/11 Gillians Well, Calthwaite: RESOLVED** that Councillor Harris had met with residents of the new development, and been informed of two issues. Firstly, issues with the wall at the well itself, and secondly issues related to building compliance, leading to a dispute with residents and the management company. Westmorland and Furness Councillor Carrick has been raising the latter matter with Building Control, and the Clerk was requested to send a letter supporting residents concerns. The Parish Council has agreed to repair the wall at the well, and a quote has been received, however it was agreed to obtain further quotes. Councillors to pass on details of contractors to the Clerk.

**09/25/12 Plumpton bench: RESOLVED** that two quotes had been received, with one specifying powder coating, the other unclear. Councillors requested the Clerk to confirm if the second quote included powder coating, and if so, to authorise the work.

**09/25/13 Warding arrangements: RESOLVED** that Councillors agreed a restructuring of wards would be more appropriate for the Parish, and proposed five wards of three Councillors each. This will be fed into an upcoming review to be conducted by Westmorland and Furness Council.

**09/25/14 Play area: RESOLVED** that the contractor had purchased a new gate fixing to resolve the issue. Due to an increase in disposal costs, the Clerk was requested to investigate further funding for the path.

**09/25/15 Grant request: RESOLVED** to award the following grants donations;

- a) Resident concerns over siting of Fibrus poles.

**09/25/19 Parish Maintenance: RESOLVED** that the following issues were raised;

- a) Councillor Campbell - the triangle school sign at the bottom end of High Hesket is upside down.
- b) Councillor Campbell - the red school road markings at High Hesket have worn away.
- c) Councillor Campbell – the path between High Hesket and Court Thorn surgery has become very worn, with potholes.
- d) Councillor Campbell – raised issues erecting the noticeboard in High Hesket, with concerns over liability. It was agreed to authorise payment to have it put up.
- e) Councillor Waugh – noted that a new light pole had been sited in Southwaite.
- f) Councillor Martin – a light in High Hesket that had fallen after apparent damage has been removed.
- g) Councillor Pollock – the footpath along the A6 is obstructed by weeds.
- h) Councillor Graham – noted the work of a resident who voluntarily cut the grass at Petteril Bridge, Plumpton. It was agreed to send a thank you card.
- i) Westmorland and Furness Councillor Carrick informed the meeting that they had been contacted by a resident regarding traffic and damage at Crook Bridge. Concerns over signage had also been reported.

- a) Councillor Waugh raised resident's concerns over the smell from muck spreading near Southwaite. Residents to be advised to contact Environmental Health if ongoing concerns.
