Minutes of the Ordinary Parish Council Meeting of Hesket Parish Council held on Tuesday 13th January 2026 at 7.30pm at Low Hesket Village Hall.

01/26/1. **Apologies for absence: RESOLVED** that the following apologies were received:

Councillor Dowes, due to previous engagement.

Councillor Everingham, due to ill health,

01/26/2. **Declarations of interest: RESOLVED** that there were no declarations to be made.

01/26/3. **Minutes: RESOLVED** that the minutes of the Ordinary Parish Council Meeting held on Tuesday 11th November 2025 and the Ordinary Parish Council Meeting held on Tuesday 2nd September 2025 were both agreed as a true record and signed by the Chair.

01/26/4. **Matters arising from the Minutes: RESOLVED** that there were no matters arising.

01/26/5. **Public participation: RESOLVED** that the following matters were raised:

- A member of the public raised concerns regarding lorries using the road at Crooks Bridge. The resident showed the Council photos of HGVs and agricultural vehicles which have been unable to navigate the road, having to turn around in a confined space. Issues are exacerbated by poor road conditions. Signs have previously been placed to deter lorries, but one of these is missing. The situation is dangerous for pedestrians, cyclists and horse riders. Councillor Carrick discussed the matter with the meeting, agreeing that there are ongoing issues, with the road highly unsuitable for HGVs and agricultural traffic. There are particular difficulties in restricting certain vehicles. Councillor Carrick will request speed monitoring, which will also provide information on the weight of vehicles using route. A bespoke solution is required. Councillor Carrick to take forward.

01/26/6. **Westmorland and Furness Council Report: RESOLVED** that Councillor Carrick raised the following matters;

- Devolution – The new combined authority will be formed in the next few months. The joint committee are currently engaged in recruitment to senior posts and a draft constitution has been produced.
- Council budget – Central government funding is determined by a national formula, called the fair funding formula. This has recently been reassessed, with greater emphasis on urban deprivation and less emphasis on the cost of providing rural services. Westmorland and Furness will receive a lower grant allocation. At the Cabinet meeting in December an update on finances was provided, with a forecast of an approximate £10 million overspend at the end of financial year.
- Budget consultation – The Council launched its budget consultation on 16th December. Proposals are for a 4.99% in Council Tax, an increase in fees and charges across the board at 3.8%, and a 10% increase in car park charges. Option for garden waste proposed are for one free bin with a £60 annual charge for additional bins, or for a £60 charge for any green waste bin for all bins.
- Councillor Carrick reported back on issues at with parking at High Hesket which has caused obstructed bus access. This has been passed on to highways, but if there is an obstruction, it is a police matter. Councillor Carrick to provide cones to church to try to alleviate issues.

- Councillor Carrick reported back on the issue of bad odours at Southwaite. Environmental health officers have visited three times, and contacted complainant. There is no evidence of an issue at the present time.
- With regard to grass cutting along the Daffodil Walk at Low Hesket, Councillor Carrick confirmed that the area falls outside the Council’s grass cutting remit.

01/26/7. **Gillians Well, Calthwaite: RESOLVED** that Councillor Harris confirmed that repairs to the wall are appreciated by local residents. Genesis Homes have begun remedial work has started on site, with the Westmorland and Furness enforcement officer continuing to work with Genesis to resolve issues.

01/26/8. **Call for Sites: RESOLVED that** Councillors were informed that Westmorland and Furness Council had launched a second Call for Sites for the Local Plan, due to insufficient sites being put forward. The sites submitted in the first Call for Sited had been assessed in the first instance for constraints. The Council is not conducting consultation at this time, but will be consulting with Parish Councils and other stakeholders in the near future.

01/26/9. **Noticeboards: RESOLVED** to order two three bay noticeboards, for Low Hesket and Armathwaite.

01/26/10. **Green Waste Collections: RESOLVED** to pursue options for extra skip collections.

01/26/11. **Policies: RESOLVED** that the following policy was approved as amended;

01/26/13. **Fellrunner Bus Service: RESOLVED** that Councillor were presented with further information from the Fellrunner Bus Service and agreed to a grant of £479.

- Councillor Graham - the bench at the bus stop of the southbound A6 at Plumpton, is not repairable. Contractor has suggested that the seat could be replaced with wood, and ornate metal sides repaired. Councillor Graham to ask for images and bring to March meeting.

01/26/18. **Council matters: RESOLVED** that the following matters were raised;

- Councillor Waugh - Calthwaite Road, from crossroads down to bridge, drains need clearing as gravel gathering at base under bridge causing flooding.
- Councillor Graham – A6 layby, litter is causing an issue.
- Councillor Campbell – the sign outside High Hesket school has not been replaced, and painting on road has not been renewed.
- Councillor Gibson – pot holes, Ling to Harrington Ling Farm, Southwaite, to Peteril Bridge End, Ling Top, Southwaite to Petteril Bank Ford, Southwaite, Winderbog to Ewelock particularly bad pot hole. Under railway bridge at Petteril Bank, the road is eroding. The tree outside village hall is potentially dangerous and could hit hall if it falls – Clerk to discuss with Highways.
- Councillor Graham - noted ongoing issues with traffic signs left after roadworks etc. completed.
- Councillor Ryland – informed the Council that the white lines at the T junction on the Armathwaite road at Hazel Cottage have now been painted, and the pot hole opposite has been filled.
